

LAKE LUZERNE 2023 TOWN COMPREHENSIVE PLAN UPDATE

TOWN ADVISORY COMMITTEE MEETING NOTES December 3, 2023, 7PM Town Municipal Center

1. General Discussion and Comments

- a. School enrollment was highest in 1999-2000 at 1166 and has been steadily dropping to the low of 635 in 2020-2021. 2021-2022 saw the first increase in over 20 years (+16) to 651 students. Some of the drop in school enrollment 2019- 2021 may largely be due to families homeschooling.
- b. Need to do a townwide assessment of internet availability. Reliable internet is essential in order to attract people and businesses. The school conducted a survey recently and Mary Alice will try to get hold of the results.
- c. Need to assess the availability and reliability of cell phone service to improve residents' safety and quality of life. Can signal boosters be a feasible solution?
- d. Bicentennial Park is best location for playground and amphitheater. In order to incorporate these elements, the park needs to be master planned so that it is handicap accessible and all elements, including parking, are well sited.
- e. The Town Hall property has many opportunities to become a hub for other community services housing, trails, health center to name a few. A concept for the site should be developed that considers several alternatives that meet the goals and objectives of this plan.
- f. Review the parcels in the hamlet that are divided by different zoning districts. Make recommendations that resolve conflicts, as practical and feasible.
- g. Health care is still an issue with no nearby Hudson Headwaters Health Center. The closest facilities in Corinth and Warrensburg are at capacity for many if not most health services especially dental. The Town should make an effort to reach out to HH and recruit them to Luzerne.
- h. Review the feasibility of adding dock access from the lower Hudson River into the downtown.
- i. Create a landscape and management plan for the welcome center across from the rest area west of Lake Vanare.
- j. Support and invest in the visitor marketing technique of detour-detain-divest.
- k. Recruit business involvement and school in COC and community events. Could there be a successful "Community Day of Service"?
- I. Lake Luzerne Music Center is a world class facility. How can it be promoted as such and convinced to hold some events off campus?



- m. Utilize Huttopia which is trying to be a good partner and promote all events and activities in Luzerne.
- n. Try to avoid more recommendations for action items and limit more planning items.
- o. Combine recommendations that are related for no more than 10 primary projects. Provide detail so that there is a clear road map to implementation.
- p. Include a detailed implementation strategy that includes appointing 2 people to report to the Town Board on recommendations and actions that should move forward or be included in future budgets for funding.
- q. Set a public meeting date and discussed the remainder of the schedule.
